### Waccamaw Arts & Crafts Guild Annual Members' Judged Show Entry Rules and Requirements

## October 19 - 28, 2019

### Seacoast Artist Gallery at The Market Common of Myrtle Beach.

#### **Eligibility:**

Open to all artists who are members in good standing of the Waccamaw Arts & Crafts Guild. Each entry must have been created in the past 2 years, must be original and never shown before in a WACG Judged or Juried exhibit.

You may enter up to 2 artworks (see size restrictions below). No slides or photographs are required to enter. Work created in a class setting, a workshop or with the help of an instructor is **not** eligible. It is advisable to have written permission (Model Release) to use the recognizable likeness of any person; however, this is the sole responsibility of each artist.

#### Size Limits (Two Dimensional):

Artists may enter up to two artworks. One entry with a framed size that does not exceed 48 x 48 inches and one entry with a framed size that does not exceed 72 x 72 inches. All artists may enter 2 artworks, but may not enter more than one large piece (exceeding 48 x48 inches).

#### Size Limits (Three Dimensional):

The maximum size is 36" in width or depth and 60" in height. The 3-D works in this show may not weigh more than 200 lbs. Heavy pieces in excess of 75 pounds must be set up for display by the artist using an appropriate pedestal or stand.

Any work exceeding these limits will not be displayed.

#### Entry Fee:

\$30.00 for up to two (2) pieces. Pay online or make checks payable to WACG and indicate on front of check that it is for the Judged Show Entry Fee. WACG will charge a 30% commission on all sales. The Gallery will handle sales and will allow credit card purchases (2.75% fee). Each artist is responsible for all taxes and should consider this in pricing their work.

Deadline for entry: Completed Entry Form and \$30.00 entry fee must be submitted online or mailed to:

Entries must be submitted online or postmarked no later than Saturday, September 28, 2019.

#### Hanging Preparations:

All work to be hung must be framed in a professional manner and securely wired for hanging. No clip mountings will be accepted. Gallery wraps will be accepted if painted on all four edges (a continuous image from the front). Fiber art must be ready to hang with no hanger exposed or extending beyond the piece.

Some pedestals are available but 3-Dimensional artists are asked to provide pedestals if possible.

Please place artist's name and title of work on (back) upper right corner of each piece (using the labels provided) before delivery to Seacoast Gallery.

For Three Dimensional works artist information may be placed on the back or bottom.

#### **Delivery of Artwork:**

Work MUST be delivered to The Seacoast Artist Gallery on Friday, October 18th from 8 AM to 12:00 noon.

Any work that requires special handling (fragile, hazardous, etc...) or work that is deemed unsuitable for public display, may be rejected at the sole discretion of the WACG show committee.

If an item is sold, it may be taken by the buyer upon payment. No other work may be removed before closing of the show.

#### Reception:

The reception and awards presentation will be on Saturday, October 19th, 5:30 to 7:00 p.m. Winners will be announced at the reception with the exception of the **People's Choice Award** which will be announced at the closing of the show.

#### Close of Exhibit:

Monday, October 28<sup>th</sup> at 6 p.m.

Pick up: Entries must be picked up by the artist (or their representative) on Tuesday, October 29th, between 8 a.m. and 12 Noon.

WACG is not responsible for artwork left beyond the pickup date and time. It is YOUR RESPONSIBILITY to arrange for someone to pick up your work if you are not able to. Late pickups will incur a storage fee of \$5/day, and the artist may be disqualified from future shows.

Important – by entering the show the artist agrees that images of their artwork may be used by WACG in their publications.
